Directions For Use :
To defrost: Open the bottom of the pack with scissors below the zip lock seal as marked, the bag can then be re-sealed and the remaining prawns kept fresh in the freezer. Remove the king prawns from the packaging, place onto a plate, cover and defrost in a cool place for approximately 5 hours or overnight in a refrigerator. Drain the prawns once defrosted. Keep refrigerated and use within 24 hours. Ensure prawns are fully defrosted before cooking (see instructions on the bag). When added to a hot recipe dish, cook the prawns for 2-3 minutes until the prawns turn pink in colour and are thoroughly cooked. These prawns once defrosted, can also be placed a handful at a time in plenty of boiling water for approx. 1 ½ - 2 minutes, drained and placed in iced water to cool before using in salads or sandwiches. This product should not be consumed raw, please ensure fully cooked before consumption.

Storage Instructions :
Keep frozen at 18oC or below. Do not refreeze once defrosted.
