ISSUE: CABEZUELO FOODS AUDIT

As we have been informed by the management of Cabezuero Foods, it has been decided to postpone the BRC and IFS certification audit that we had planned to carry out the week of 23 May 2022.

The reason for this is the start of expansion works, warehouses and a new production line together with a new changing room and canteen area. Their decision is based on the need for expansion in order to achieve the production volume they currently require and the inclusion of the new facilities in the renewal of the certificates.

It is expected that the audit could be carried out during the month of November, delaying the renewal audit and the issuing of their certificates by a few months. However, we are in constant contact with the Head of Quality and Food Safety to monitor the extension works and plan the certification audit as soon as possible.
