Eggs are delivered into the Packing Centre, and ungraded eggs are stored in a temperature controlled environment (between 5°C and 20°C). Eggs are perched and faulty eggs are removed. Eggs go through a grader, and are then packed and labelled accordingly. The eggs are distributed using temperature controlled vehicles.
