PANINI GRILL:

Preheat grill at 180 °C. Place Panini in unopened packaging on the panini grill. Cook for 10 minutes. Ensure product reaches a minimum 75°C throughout the product before serving.

MICROWAVE:

Place Panini, in unopened packaging onto a microwaveable plate. Microwave at 1000W for 1 minute. Allow to stand prior to consumption. Ensure product reaches a minimum 75°C throughout the product before serving.

TURBOCHEF TORNADO HIGH SPEED OVEN:

Place Panini, in unopened packaging on a tray. Cook for 50 seconds. Ensure product reaches a minimum 75°C throughout the product before serving.
