Because of this, all equipment used during the production of vegan products is swabbed with Reveal® 3-D for Total Milk Allergen Swabs which are used to test the qualitative analysis of milk residue. The swabs must all show a negative result before production can start. We contacted the Vegan Society and Campden BRI concerning this issue and they advised us, that as we are not a designated vegan factory, we should include the following statement on the specifications for our vegan products: "Produced in a factory which handles milk and therefore may contain milk."
